The More We Love / December Report

This is a 30 day report for the month of December.

- Transportation to and from DESC to obtain drivers license and identifications
- Successfully delivered many blankets, hygiene kits, food, and stay warm kids in backpacks to encampment and individuals in and around Burien
- Transportation and assistance to obtain cell phones
- · Transporting for medical appointments and assistance
- Worked alongside OPS (Operation of Prosecution Survivors) and successfully address several needs involving vulnerable and sensitive females, connecting them to case management, and getting them in an environment where they are lifted up
- Provided local sheriffs with critical response services, i.e. quickly getting people into shelter, helping people who are newly evicted, and worked as a team to get several homeless people into a housing system which will be key to getting them long term housing
- Helped de-escalate many situations around Burien to prevent arrests
- Promoted Transform Burien services and offered rides over to services
- Promoted detox and provided transportation services
- Assisted in saving an aggressive dog by getting him much needed training services, while assisting owner with next level long term shelter services
- Successfully helped move residents of illegal camp along a trail in South Burien and successfully broke down camp in less than 72 hours from first notification
- Continued to utilize Transform Burien to utilize and promote services.
- During the Month of December, we logged an average of 3-5 calls per work day from Allie & Turner
- 6-10 calls from BH team on the weekends
- 3-5 calls daily from BH team daily 8am-5pm
- 4-5 calls from rest of Sherrif's department daily 8am-5pm
- 5-8 net new case calls from entire team after hours weekly
- Successfully sheltered individual form previous Ambaum encampment and continued to
 work with him during and after work hours. Connected him with ID, cell phone, new
 clothes, and many food options. He has helped with entry level volunteer duties like
 stocking, low risk outreach touches, food/donation prep. Currently looking for detox
 and inpatient and will continue to see him through this process.
- Fielded calls from and successfully connected individuals with services from Oasis camp
- Fielded calls from and worked with cases from REACH South office
- Offered to provide shelter/housing services to Transform and within the first week received 2 calls where we were able to provide a path for the individuals

- Business Development/Relationship & Network Building Activities
- Assisted Sherriff's department with individuals involved in potential murder case spent all day transporting them to and from encampment, sitting with them during questioning and using this time to discuss next level services. We are actively creating a plan for this couple to help transition them off the streets
- Transform Burien investigating opportunities to partner to maximize the space they have. Discussed possibilities and will continue to explore building more services offered to homeless
- OPS Attended the holiday party for families, continued to partner on cases involving females who need sensitive case management
- Partnered and served Burien with up and coming outreach team that provides food, coffee, evangelical services in multiple locations around Burien
- Established contact with and developed relationship with PHRA
- Established contact with outreach and housing team from Urban League that is servicing
 Oasis encampment. We discussed ways to partner in Burien to get more services in the
 area. Will continue to pursue this relationship as a force multiplier for ongoing outreach
 efforts
- Called on UpLift Seattle to see if they provide mobile outreach job resources that could be deployed in Burien. Assuming they do we will get them down here to bring job options to people, if they do not we will work with them until they do. We promote and transport to UpLift where there is interest
- Utilized Tent City 3 in 2 situations where it was a good option for people to be in Seattle, away from risky situations, closer to other resources or family
