# Exploitation: Rooted in Oppression

Exploitation is deeply embedded in gaining power and control over another person. It stems from slavery and colonization. It does not require that someone physically forces, abuses, or restrains someone else. When one is not in a position to give consent and it doesn't matter whether or not you're receiving payment when there is a major power imbalance.

# Human Trafficking, Defined

The recruitment, transportation, transfer, harboring, or receipt of individuals through **force, fraud, or coercion** for the purpose of exploitation. This exploitation can include forced labor, sexual slavery, or other forms of commercial sexual exploitation. The coercion can be subtle or overt, physical or psychological.

Exploitation of a **minor** for commercial sex is human trafficking, regardless of whether any form of force, fraud, or coercion was used.

It is considered a form of modern-day slavery, affecting people of all ages and backgrounds.



# Washington: The First State to Criminalize Human Trafficking

---

Washington was the **first State** to enact a criminal Human Trafficking statute modeled on the Federal crime of Human Trafficking (2003)

---

**Safe Harbor Laws** - Protects minors from being prosecuted for prostitution (2020)

---

**Vacating Convictions** - Allows survivors to clear records tied to trafficking (RCW 9.94A.640)

---

**Affirmative Defense** Prosecution for Prostitution - that the actor committed the offense as a result of trafficking (RCW 9A.88.040) (2012)

---

**Survivors FIRST** – a KCPAO program that declines to file charges against victims of trafficking, facing criminal charges—refers culturally responsive, trauma-informed services.

# Vulnerable Populations: Who's Most at Risk

BIPOC Women & youth experiencing self-esteem issues, immigration, instability, history of sexual abuse or runaway, LGBTQ+, homelessness, normalization of prostitution



# Disproportionate Impact of Human Trafficking on BIPOC Girls and Women

- Of the more than 10,000 cases reported to the National Human Trafficking Hotline, nearly 40% were Black women and girls—the highest of any racial group. (

*- Rights4girls – Child Sex Trafficking & Black Girls*

- According to the National Criminal Justice Training Center, 40% of sex trafficking victims in the United States identified as Native American, despite being only 3% of the population.

- In Seattle, 94% of Native women were forced or coerced into sex in their lifetimes.

# Adultification of Black Girls in the Sex Trade

*Rights4girls – Child Sex Trafficking and Black Girls*

---

Adultification - form of intersectional bias against Black girls that perceives them as older and less innocent than their white peers.

---

Stereotypes attributed to Black women are projected onto Black girls, leading to their hyper sexualization and the perception that Black girls exercise more agency when engaging in the commercial sex trade even when they are too young to consent.

---

On average, only 30% of Black youth are characterized as victims compared to 66% of their white counterparts.

# R.I.S.E. Report - Impacts of the Commercial Sex Industry on Black/African American Communities in Washington

- Data from the National Human Trafficking Hotline shows that among sex trafficking victims in Washington who reported their age of entry into exploitation, **89% reported that they were children when first exploited.**
- **Nearly all participants exploited by a third party reported multiple, concurrent vulnerabilities**, ranging from the need for shelter, food, and clothing to gaining access to controlled substances or previously unattainable items, and fulfilling emotional needs such as love, family, and belonging.

## R.I.S.E. Report Cont.


- Most survivors spoke at length about the normalization of sex work in their childhood homes and in their surrounding communities. These survivors primarily talked about their mothers' and other female role models' involvement in the commercial sex industry, and to a lesser extent, their fathers and male role models as pimps.
- “Almost all of the children that I've served have been recruited or solicited online almost exclusively - like I can think of in the last year every single one has been an online solicitation.” – *Statement from a study participant speaking to the frequency of online solicitation*

# The Demand Driving Trafficking: Sex Buyer Demographics

- In King County between 2014-2023 71% of men charged with attempting to buy sex from minors were white males.

- Buyers are found across all income groups; however, currently active, high frequency buyers are much more likely than other men to make \$100,000 or more annually

# Dehumanized and Disposable: The Cruel Perceptions Fueling Human Trafficking

A review of posts on a sex buying chat room found that the majority of the posts expressed contempt for prostituted women and girls, often referring to them as “meat” or “merchandise.”

Buyers in online chat rooms in Illinois admitted to being violent or aggressive to women in prostitution; recognize the harm they and pimps/traffickers do to women but continue to buy sex despite the harm; recognize the extreme youth of some prostituted women but are not deterred from buying (raping) children.

## Johns Aren't Gentlemen: The Violent Truths About Sex Buyers

- One study found that:
- 43% of men believed that if men pay for sex, the women should do anything they ask.
- 75% of men have seen women with a pimp.
- 40% of men knowingly bought a woman in prostitution who was under pimp/trafficker control.

## Johns Aren't Gentlemen: The Violent Truths About Sex Buyers cont.

- 21% of women in escort services stated they had forced sex **more than 10 times**, virtually the same percentage for women in the streets and in their own private homes.

- One woman reported that the following objects had been shoved into her body, 'fruit, broomstick, a ferret, perfume bottle, nightsticks, nunchucks, a sex toy with tape on it, and a hand with bracelets still on.'

- Research done in Chicago found that moving prostitution indoors does not make prostitution "safe." The severity of violence in indoor venues in this study was high, and in some types of violence even higher than for street prostitution.

*“Once with a petite little spinner abt 40  
who told be [sic] no bj [blowjob], but  
then I simply insisted firmly ‘yes. You  
suck.’ and I grabbed her head and she  
didn’t resist. That was one of the wildest  
mp [massage parlor] experiences I’ve  
had because I completely face fucked  
her to where she puked on the floor  
twice and would clean it up then come  
back to me where I would fuck her face  
silly again. I even had her licking my  
asshole that time...I think I gave her  
.80.”*

# Dehumanized and Disposable: Sex Buyers Own Words

## Dehumanized and Disposable: Sex Buyers Own Words

*“Prostitutes are like a product, like cereal. You go to the grocery, pick the brand you want, and pay for it. It’s business.”*

*“She has no rights because you are paying for a sex act- she gives up the right to say no.”*

# The Cost of Exploitation: Health Impacts on Victims

According to a Colorado medical study examining two decades of evidence, the mortality rate of women in prostitution is 200 times the rate of the general population.

Individuals engaged in prostitution suffer from PTSD at 53% compared to a 51% prevalence of PTSD among combat veterans.

## The Cost of Exploitation: Health Impacts on Victims cont.

Women also face exposure to STDs, HIV, and difficulties in access to treatment. Coercion into abortions, sterilization, or forced pregnancy. They may also suffer from pelvic floor degradation, urinary tract infection, bladder inflammation, fecal incontinence, infertility, cervical cancer, oral illnesses, or sleep disorders.

# Voices of Survival

*Torture and Its Sequelae Among Prostituted Women in the United States*

*“When a pimp says he’s going to torture you, what I’ve seen is girls in dog cages, girls being waterboarded, stripped down naked and put in the rain and cold out-side and having to stand there all night, and if you move, you’ll get beaten. I’ve seen girls get hit by cars and stunned with stun guns...I’ve seen girls burned and strangled...If you want to use the restroom, you have to ask. If you want to eat, you ask, and if you don’t get permission, you just don’t do it. It’s more than physical domination. It’s emotional and mental, and that’s the domination that tends to linger.”*

## Voices of Survival

*“A week into the job, I started vaginal bleeding, probably due to overworking my body, so I informed her, saying I couldn’t continue. But, she pressed me to keep working with cotton pads packed in the vagina during intercourse, saying that customers wouldn’t notice. So I repeated every hour the process of packing in and removing the bloody cotton pads from my vagina so as to hide the bleeding from customers per her instruction.”*

# What can be done to protect survivors?

**HB 2526:** a bill to stop the extreme physical and sexual violence against children and women that is directly driven by sex buyers using their money to buy sexual access to vulnerable people.



Heard by the House Community Safety Committee on January 20.  
Needs Committee vote of approval by February 4

## What can be done to protect survivors? (cont.)

**"Patronizing prostitution"** currently carries less of a penalty than stealing a candy bar.

By raising the penalty to a class c felony and doubling the fines/fees, **HB 2526 will 1) protect survivors, 2) discourage demand by holding sex buyers accountable, 3) incentivize law enforcement to investigate more cases, and 4) generate revenue for survivor services.**

This is a critical moment to enact this policy before the World Cup.
